SUBMITTING ENTRIES

Mail ALL entries to: Norman Pope, 38627 279th Street, Armour, SD 57313. Payment may be made by cash, check, or money order. No entry will be accepted without payment. **Make checks and money orders payable to Northern Plains EBGDC.** Checks and money orders must be payable in U.S. funds. Post-dated checks or returned checks do not constitute a valid entry. NPEBGDC will add a collection fee to the amount of each returned check or money order. Exhibitors who repeatedly submit invalid entry fees may be put on a CASH ONLY basis.

REFUNDS

No refund of entry fees will be made for entries cancelled after the Entry deadline, except in the cases of bitches that come into season. In those cases, refunds may be obtained by providing NPEBGDC with a veterinarian's certificate verifying that the bitch came into season after the closing date. The certificate may be mailed, provided the postmark is no later than the date prior to the day of the trial, or delivered by hand to the NPEBGDC Event Committee before the start of the TAN or Field Trial.

LIMITATION ON NUMBER OF ENTRIES

There is a limited number of entries. The limit will be 10 dogs for open braces, 14 dogs for open solo, 14 dogs for gun solo and 10 for gun braces (GUN BRACES SATURDAY ONLY).
